



<b>SCHOLARSHIP TERMS AND CONDITIONS</b>	
<b>Scholarship Name</b>	<b>2025 University of Adelaide Global Citizens 15% International Scholarship</b>
<b>Scholarship Value</b>	Reduction of 15% of the international tuition fee.
<b>Scholarship Duration</b>	For the minimum standard full-time duration of the recipient's undergraduate or postgraduate coursework program at the University of Adelaide ("UoA"), as specified on the Offer of Admission and accepted by the candidate.
<b>Scholarship Eligibility</b>	<ol style="list-style-type: none"> <li>1. The Scholarship is awarded based on academic merit.</li> <li>2. UoA will offer candidates the Scholarship to study an undergraduate or postgraduate coursework program at the University of Adelaide ("UoA") (excluding the Excluded Programs) ("<b>Program</b>") where all of the following requirements are satisfied: <ol style="list-style-type: none"> <li>(a) the candidate has achieved a <b>minimum</b> of: <ol style="list-style-type: none"> <li>i. <b>ATAR of 85</b> (or comparable score) for entry to an undergraduate (UG) program; or</li> <li>ii. overall <b>GPA of 5.5 on a 7.0</b> scale or comparable score for entry to an UG or PG coursework program; or</li> <li>iii. overall <b>GPA of 5.0 on a 7.0</b> scale for studies completed at the <b>University of Adelaide</b> (or with a comparable score for studies at an Australian University where studies are completed in Australia) for entry to an UG or PG level award program; or</li> <li>iv. successful completion of an Australian vocational qualification in Australia with an overall grading of a non-graded pass (competency-based); or</li> <li>v. GPA of 3.0 on a 7.0 scale for studies completed at the University of Adelaide College Degree Transfer Program (DTP) or Pre-Masters Program (PMP) programs for entry to an UG or PG coursework level award program; or</li> <li>vi. GPA of 3.0 on a 7.0 scale for studies completed at Eynesbury College Diploma programs for entry to an UG level award program; or</li> <li>vii. grade of 65% for studies completed at the University of Adelaide College Foundation Studies Programs for entry to an UG level award program; or</li> <li>viii. score of 319 for studies completed at Eynesbury College Foundation Studies Program for entry to an UG level award program;</li> </ol> </li> <li>(b) the candidate has received an Offer of Admission for full time study to the Program from UoA; and</li> <li>(c) the candidate is not an Australian Citizen, a New Zealand Citizen or a holder of an Australia Permanent Residency Visa.</li> </ol> </li> <li>3. Eligibility for the Scholarship is assessed automatically at the time of application. Candidates will be notified of the offer of Scholarship in the Offer of Admission to the Program. Candidates must accept the Scholarship offer and admission strictly prior to the lapse date specified in the Offer of Admission.</li> <li>4. The following persons are <b>not eligible</b> for the Scholarship: <ol style="list-style-type: none"> <li>(a) a person who is already receiving an alternative scholarship from UoA. UoA will award the highest value scholarship the candidate is eligible for at the time of application; and</li> <li>(b) a person who is receiving a scholarship or sponsorship awarded by a scholarship or sponsoring body recognised by UoA such as a Government ministry or department ("<b>Grantor</b>") where the value of the award is greater than 50% of the tuition fees for the Program. This sub-clause 6(b) does not apply where UoA and the Grantor are parties to an agreement under which the Grantor has agreed to sponsor students to study the Program at UoA, in which case the person may be an eligible for the Scholarship.</li> </ol> </li> </ol>
<b>Scholarship Terms and Conditions</b>	<ol style="list-style-type: none"> <li>5. It is a condition of the Scholarship that the recipient must maintain during the Program: <ol style="list-style-type: none"> <li>(a) unless otherwise expressly provided in these terms and conditions, a full-time study load for each study period;</li> </ol> </li> </ol>

- (b) a minimum overall **GPA of 4.5 on a 7.0 scale ("Minimum GPA")**; and
  - (c) an enrolment status as an international student\*.
6. A review of academic progress will be carried out each teaching period to ensure the recipient continues to meet the conditions of the Scholarship. Should academic progress not be satisfactory for two consecutive semesters or the recipient withdraws from the program, then the Scholarship will be terminated and will cease.
  7. The Scholarship cannot be transferred to another program. A new application is required for any new UoA program.
  8. UoA will apply an international tuition fee waiver directly to the tuition fee account of the recipient. The tuition fee waiver will reduce the recipient's tuition fee liability by the Scholarship Value for each teaching period of the Scholarship Duration. The tuition fee waiver may not be reflected on the recipient's tuition fee account until the census date of their intake.
  9. The recipient will have full responsibility for:
    - (a) the residual balance of the tuition fees payable for the Program; and
    - (b) all other fees and expenses associated with the recipient's participation in the Program, including the costs of visas, Overseas Student Health Cover (OSHC), Student Services Amenities Fee (SSAF), travel, accommodation, living expenses, textbooks, study materials or any other expenses associated with living in Adelaide or study at UoA.
  10. The Scholarship does not cover, and the recipient will be liable for, any additional tuition fees payable by the recipient for:
    - (a) coursework in which the recipient is enrolled which is not part of the Program;
    - (b) if a recipient does not complete the Program within the duration specified in the Offer of Admission, the following period of study until the Program is completed;
    - (c) any courses or subjects of advanced standing or credit which have been granted to the Program; or
    - (d) any courses enrolled in another institution, including cross-institutional study.
  11. The Scholarship is not transferable to a third party or redeemable for cash.
  12. Recipients must commence study in the Program in the study period for which the scholarship was offered. The Scholarship cannot be deferred to a different commencing intake.
  13. If UoA approves the recipient to take a leave of absence due to exceptional circumstances requiring them to return home, the recipient may apply for a deferment of enrolment in the Program for a maximum of one year without loss of the scholarship, provided this is permitted under the recipient's visa requirements.
  14. If a candidate receives more than one Offer of Admission with scholarship for the Program, the latest Offer of Admission with scholarship will supersede any previous offer issued to the candidate.
  15. The Scholarship offer will be withdrawn by UoA if the recipient's Offer of Admission is withdrawn for any reason. The recipient will be liable for all tuition fees if the Scholarship is withdrawn.
  16. UoA may terminate the Scholarship if the recipient:
    - (a) does not comply with the rules, policies and procedures applicable to students of UoA from time to time, including without limitation student codes of conduct;
    - (b) does anything that damages or is likely to damage the reputation of UoA, including engaging in disparaging comments regarding UoA or its Program;
    - (c) fails to pay their international tuition fees within the payment deadlines stipulated by UoA;
    - (d) has supplied incorrect or misleading information in or in relation to their application for admission to the Program;
    - (e) is expelled, terminated or withdraws, from enrolment in the Program prior to completing the requisite courses; or
    - (f) is, in the reasonable opinion of UoA, not complying with these Terms and Conditions.
  17. The recipient must notify UoA immediately if they intend to:
    - (a) transfer to another program within UoA;
    - (b) discontinue full-time study in the Program;
    - (c) transfer to another institution;
    - (d) seek a retrospective withdrawal from any requisite courses they have enrolled in; or
