

TERMS AND CONDITIONS

Scholarship Name	The 2021-2025 Eynesbury College High Achiever Progression Scholarship
Scholarship Value	This scholarship offers a reduction of 25% of the tuition fee. Up to 100 commencing international students with a minimum grade average 85% or a GPA of 6.0/7.0 or above in their last program studied at Eynesbury College prior to progressing to the University of Adelaide will be eligible.
Scholarship Duration	For the minimum standard full-time duration of the scholar's chosen undergraduate or postgraduate program
Payment details	The scholarship payment will be made in the form of a tuition fee waiver directly into your tuition fee account thereby reducing your tuition fee liability by the scholarship amount for each teaching period during the specified duration of study. Please note that the tuition fee waiver may not be reflected on your tuition fee account until the census date of your intake.
Scholarship conditions	<p>This scholarship is subject to the following terms and conditions:</p> <ol style="list-style-type: none"> 1. The following students are not eligible to receive this scholarship: <ol style="list-style-type: none"> a) Students who have not received an offer for the scholarship. b) Students who are recipients of a scholarship awarded by a recognised scholarship awarding body such as a government ministry or department. c) Current University of Adelaide students who are transferring from one program to another prior to successful completion of their program of study (internal transfer students). 2. This scholarship is applied automatically at the time of offer. Students will receive notification of the scholarship with their offer. 3. The scholarships provide a tuition fee waiver of the scholarship value for the duration indicated in the scholarship award letter for study at the University of Adelaide. The scholarships do not cover the costs of visas, Overseas Student Health Cover, travel, accommodation, living expenses, books and study materials or any other expenses associated with living in Adelaide or study at the University of Adelaide. 4. The scholarship is not paid for courses where credit is granted in recognition of prior learning/study. 5. The scholarship is not transferable to a third party or redeemable for cash. 6. If an individual receives and accepts more than one offer of a scholarship from the University of Adelaide, only one scholarship, the scholarship of greater value, will be awarded. 7. Scholarship holders must commence study in the University of Adelaide in the Semester for which the scholarship was offered. The scholarship cannot be deferred. 8. The scholarship holder must be enrolled in the undergraduate or postgraduate program of study for which the scholarship was awarded. 9. Scholarship holders are required to enrol in the University of Adelaide program of study as international students* and must maintain international student* status for the duration of their enrolment in the University. The scholarship will be terminated if a student ceases to be an international student*. 10. Scholarship holders are required to enrol in a full time study load for each study period of their degree. 11. If a scholarship holder enrolls in more than the standard full time unit load required for the year, or in any way accrues additional tuition fee liabilities, the additional tuition fees are not covered by the scholarship. 12. The scholarship holder must pay their tuition fees within the stipulated payment deadlines. 13. If a scholarship holder faces exceptional circumstances requiring him or her to return home they may apply for a one year deferment of enrolment without loss of scholarship, provided this is approved under the student visa requirements.

	<p>14. If a scholarship holder enrolls in courses in another institution, including cross-institutional study, those tuition fees are not covered by the scholarship.</p> <p>15. If a scholarship holder is required to repeat a course the student is liable to pay for the tuition fees for the repeated course.</p> <p>16. The University does not represent that this scholarship will be tax free to the recipient. The recipient should seek independent advice on the tax implications of this scholarship.</p> <p>17. The scholarship holder agrees to notify the university by sending an email to ask@adelaide.edu.au immediately if the scholarship holder intends to:</p> <ol style="list-style-type: none"> Transfer to another undergraduate program within the University. Discontinue full-time study. Transfer to another institution. Seek a retrospective withdrawal from any courses they have enrolled in. To defer their studies and/or apply for Approved Leave. <p>18. The University reserves the right to vary the awards, withdraw or not to offer scholarships if:</p> <ol style="list-style-type: none"> applicants have not achieved or cease to meet the eligibility requirements of the awards; or the scholarship holder has been found to have supplied incorrect or misleading information during the application process; or a scholarship holder fails to maintain good academic standing and progress; or there is a case of serious misconduct by a scholarship holder; or in any other case where the University determines that the scholarship eligibility requirements have not been met. <p>19. The scholarship holder Students may be required to participate in a photo shoot and complete a testimonial for the University, which may be published on our website or used for other promotional purposes. The scholarship holder must be willing to be featured in such promotional collateral produced by the University and be involved in promotional activity arranged by the University. Accepting the terms and conditions of this scholarship confirms a scholarship holders consent to be used for promotional purposes.</p> <p>*An International student is a student who is not an Australian Citizen, a New Zealand Citizen or a holder of an Australia Permanent Residency Visa.</p>
